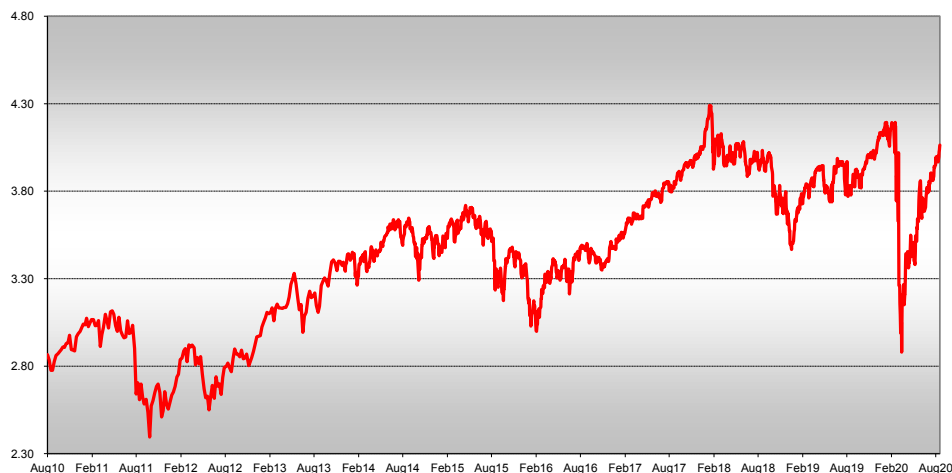


**HLM Fund Info Sheet as at 28 August 2020****Investment Objectives**
