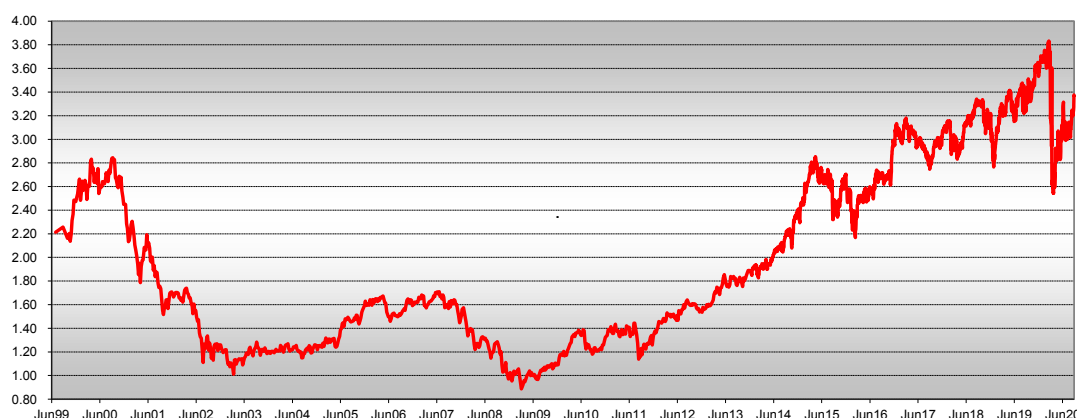


HLM Fund Info Sheet as at 28 August 2020**Investment Objectives**

The underlying fund or funds seeks to achieve long-term capital growth expressed in euro by primarily investing in equities of companies domiciled in, or exercising the predominant part of their economic activities in the United States. Exposure to securities is achieved through investment in an underlying fund or funds which may be denominated in other currencies than the euro. Currency risk arises from fluctuations in the value of the euro against the base currency of the underlying fund. The underlying fund may invest in financial derivatives, other financial instruments and engage in leverage which may result in the overall risk exposure of the underlying fund to exceed their total net assets. For operational purposes the HLM Fund may hold a proportionately small amount of its holdings in cash.
